STUDENT SCHOLARSHIP PROGRAM PROCEDURE



GOAL

In an effort to encourage outstanding undergraduate students whom with an excellent academic records and exceptional moral characters but lack financial measures to pursue their higher educational studies, the foundation established following criteria for the scholarship:

MAIN CRITERIA:

- Extracurricular activities in art, sport, research, and community involvement
- Financial constraints or an income under a set amount
- Applicants are ineligible if they have received scholarships and/or awards from any other organizations

FEATURES AND ADVANTAGES:

Scholarship award winners are eligible to apply for membership with the foundation, allowing students to participate in further events and activities organized by the foundation. More importantly, the foundation will have to review the qualifications of each recipient of the scholarship award for subsequent years and evaluate achievements and extracurricular activities by the fall of each year.

This is a classic example where our students always act as role models in classes and society due to their honesty, kindness, and integrity as well as knowledge.

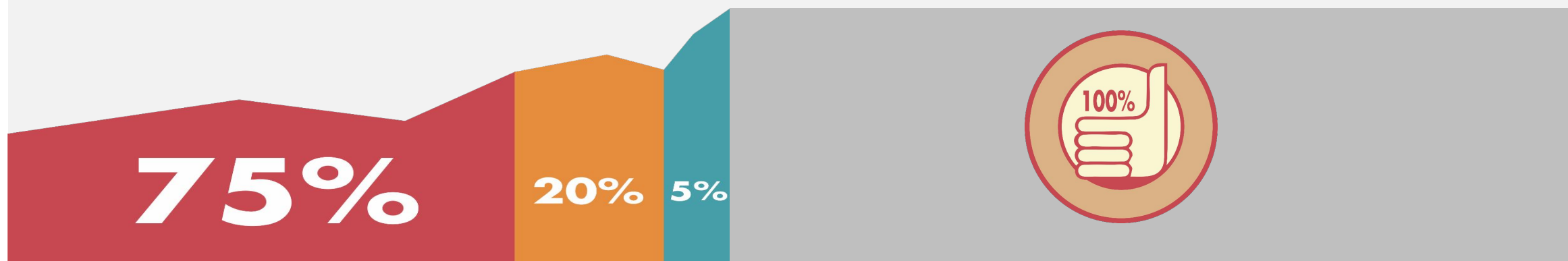
SCHOLARSHIP PROGRAM



Since its inception in 2006, founders of “**BADRAA FOUNDATION TO JUSTICE**” have been hosting an annual “undergraduate student scholarship in honor of Badraa” with the purpose of supporting students with an excellent academic records and exceptional moral characters. Although in the first four years, awarded students were only from National university of Mongolia, beginning 2010, students from Institute of Finance and Economics started being available to be awarded with scholarship that covered fully and/or partly tuition payments which totaled to 36 students.

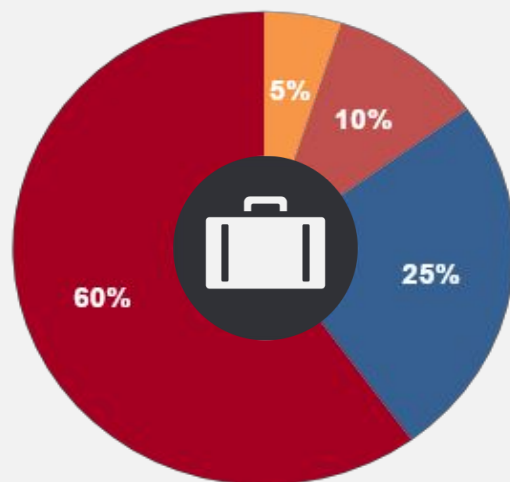

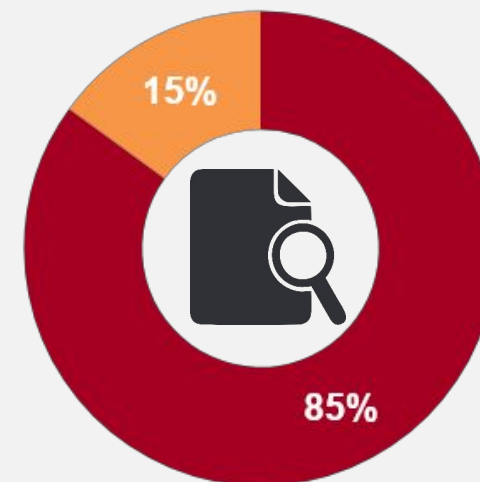

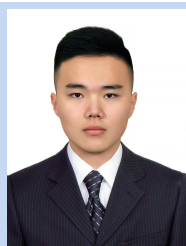


Job positions of scholarship recipients

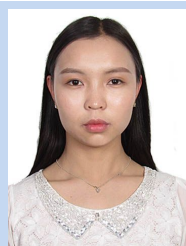

LEGAL OPPORTUNITIES FOR INVESTORS

Business Entity Income Tax Law Of Mongolia - Chapter 6: Tax Reduction and Exemption (Article 22)

22.9. For the purpose of supporting activities carried out within the framework of social responsibility that are unrelated to the income-generating activities of the taxpayer, investments made in depreciable fixed assets, financial assistance, and donations granted to unrelated parties shall be deducted from the tax imposed under Article 20.1 of this Law. The amount of such deduction shall not exceed one (1) percent of the taxable income for the respective tax year.

Education & Research Incentives - **22.9.8**

Scholarships granted to universities, institutions of higher education, or the Academy of Sciences for the **purpose of conducting research and studies;**
